Michigan Energy Options (MEO) is a nonprofit that embodies and practices the positive principles of sustainability.

Our 34-year-old organization has foundational stability; we are growing in ways that are smart and essential to our cause; we are an economic catalyst in this state through the work we deliver and the jobs we create; and, importantly, our progressive energy and sustainability programs benefit people and the planet.

Stability

Our mission to guide communities to be more energy efficient and sustainable has remained the same across the decades. Our way to accomplish our mission has not: today, we are more business-friendly, more collaborative with public- and private-sector partners, operate in larger ways-regionally and statewide, and we are developing more innovative solutions based on our intellectual capital and years of experience.

- Programs funded by state, federal, corporations, and donors.
- Founded in 1978, and recognized by the State of Michigan as the first Energy Demonstration Center.
- A credit score of 100, in continuous operation, robust oversight by board of directors.

Smart Growth

Our team of professionals has diverse skills that position us as strong thinkers and doers. PhD, MBA, MPA professionals coupled with architects and builders, and LEED and BPI accredited specialists, ground our mission in the real world. The real world, however, keeps changing so MEO has committed itself to creating a culture that is restless. We are relentless in seeking solutions that work: impactful, costeffective, and doable.

Our staff has doubled to 20 in the last two years, we have offices in three locations in the state and are planning a fourth, we are engaging national and regional partners to infuse our work, and we have diversified our funding, tacking away from state support and towards federal, contractual, corporate, individual, and foundations.

- Increase in revenue and staffing by 200% and 400%, respectively, in last three years.
- Managed \$10 million of funding across 40 programs in last three years.
- Fiscally responsible: Our overhead is 10% and independent audits have been affirming.
- We are the only energy nonprofit in the Upper Peninsula.

Economic Catalyst

MEO has brought federal funding into the state, such as a recent HUD Sustainable Communities grant. We have executed a number of statewide market transformation programs to provide emerging energy efficiency and renewable technologies traction. We have also served as an "energy career starter kit" for many recent college graduates by providing good jobs. During Michigan's prolonged recession, MEO has been a counterpoint to out-migration and has provided work for a retrained workforce.

- HUD Sustainable Communities grant for Mid-Michigan, leveraged to \$8 million.
- MEO employs Michigan residents, adding 10 recent graduates from state universities in the last two years.
- Our programs have employed subcontractors from Michigan companies, providing them an estimated \$3 million in revenues.
- Our programs have saved \$5 million in energy costs for Michigan residents and businesses

- The last four years of our work has reduced the need for 80 million kWh of power, and has removed the CO₂ equivalent of taking 8,000 cars off the road each year.*
